COURTESY SALES AGREEMENT

The applicant agrees with the Seller, East Coast Lumber & Supply Company, to pay for all purchases upon receipt of monthly statement. All purchases are net unless otherwise indicated on the statement, and credit limits may be established where deemed necessary by East Coast Lumber & Supply Company.

The applicant authorizes the Seller, East Coast Lumber & Supply Company, to request credit information from reporting agencies of its choice. Information contained on this application may be used as identification to obtain transcripts of credit information. The transcript is to be utilized for the sole purpose of reviewing the accuracy of the information stated on this application.

Charges billed, but not paid in full by the 11th day of the month following purchase will be considered past due. The applicant hereby agrees to pay a service charge of 1-1/2% per month (18% per annum, minimum charge \$1.00 per month) on all past due accounts. Further, the applicant hereby agrees to pay all collection expenses, including reasonable attorney's fees and court costs, if it becomes necessary to collect the account through legal action.

The applicant assumes full responsibility for all materials purchased from East Coast Lumber & Supply Company. In addition, all persons signing this application in behalf of a corporation or partnership seeking credit purchases from East Coast Lumber & Supply Company personally guarantees payment of the account, and further agrees that liability shall be joint and several. The applicant further agrees to notify East Coast Lumber & Supply Company, in writing, within ten (10) days of receipt of the monthly statement, of any discrepancies in the billing. Failure to notify East Coast Lumber & Supply Company signifies total acceptance and responsibility for prompt payment, in full, of the account.

Any limitation to the individual(s) who are authorized to charge on this account must be provided in writing, and acknowledged by East Coast Lumber & Supply Company.

If materials are ordered to be delivered to a construction job site, the applicant assumes liability for the materials at the time of delivery whether or not the applicant or applicant's representative is on hand to acknowledge receipt of delivery.

The applicant agrees that no refund will be granted unless merchandise is returned within thirty (30) days of purchase with the original invoice to the store where the purchase was made, and that said merchandise is in original condition.

The applicant agrees to furnish East Coast Lumber & Supply Company with purchase orders, notice of commencement, complete job number and address, legal description of the real estate, and a list of individuals authorized to order, pick up, and sign for merchandise.

East Coast Lumber & Supply Company reserves the right to send out notices to owners, to file liens on past due accounts, and to use any legal means available to obtain payment, if such action becomes necessary.
